EYSA Parent Code of Conduct Form

As a parent of, ______, (player/cheerleader name), an Eaton Youth Sports Association, (EYSA), player/cheerleader, I understand that:

- 1) It is a privilege, not a right, for my child to participate in any EYSA sponsored activity.
- 2) Sportsmanship and fair play are essential to the sport of Football/Cheer and are important skills that our children learn from such.
- 3) Our children learn from our example, and we as parents need to exemplify the highest level of sportsmanship by supporting all players, coaches, team managers, referees and parents.

Therefore, I agree to the following Parent/Guardian Code of Conduct:

- 1) I will never use abusive behavior, including but not limited to foul language, entering the field of play, and threats of violence towards anyone involved in a EYSA sponsored event.
- 2) I will never use racially motivated comments and/or actions of any nature towards anyone involved in a EYSA sponsored event.
- 3) I will encourage good sportsmanship by demonstrating positive support for all players, cheerleaders, coaches, fans, volunteers and referees at every EYSA sponsored event.
- 4) I will not create a public display of anger toward home or visiting coaches, players, referees or spectators in any venue including e-mail, letter, and/or by phone call.
- 5) I will respect and adhere to all rules, by-laws and Code of Conduct of the EYSA and the Metroplex Youth Football Association, (MYFA).
- 6) I will express any concern through proper channels in a respectful manner.
- 7) I understand that any parent who cannot abide by these rules or violates them will be subject to disciplinary action including but not limited to the removal from the venue and a ban from attending future EYSA sponsored events until approved by the EYSA Executive Board at the next scheduled meeting.
- 8) I understand any violent actions or threats of violence toward anyone in attendance of a EYSA sponsored event, including any individual associated with the visiting team, (spectators, coaches, players and League Officials), will be subject to the assistance of local law enforcement in detaining or removing all individuals in question from the venue.
- 9) Under no circumstances will I enter or attempt to enter the field of play at any home or visiting venue without proper authorization.
- 10) I understand that EYSA is a non-profit organization run by volunteers. It is my responsibility to assist with concessions, gate, and clean up responsibilities before or after each game.
- 11) I hereby give permission for images of my minor player/cheerleader listed above, captured during the season through video, photo and digital camera, to be used solely for the purposes of EYSA promotional material and publications, and waive any rights of compensation or ownership thereto.
- 12) I understand that the deadline to receive any type of refund is 24 hours PRIOR to the draft date. I am aware that being a part of EYSA is not contingent on my child playing for a certain team or with certain players. I agree to abide by MYFA's by-laws and if my child be on a team not of my choosing and I decide to cancel registration, I will NOT be owed a refund of any amount.
